FEDERAL PROGRAMS







We are providing a one-time, tax-free payment of \$300 for 6.5 million seniors receiving Old-Age Security (OAS) and \$200 for the 2.1 million lower-income seniors receiving Guaranteed Income Supplement (GIS). This will be automatically delivered the week of July 6th.

We are also funding local programs to promote wellness and social connection through the New Horizons for Seniors (NHSP) program, and to provide delivery and transportation services for seniors.

Support for Families



In May, over 6 million families received a boosted Canada Child Benefit (CCB) payment of \$300 per child to help with expenses during the pandemic.

To help support over 1 million Canadians receiving the Disability Tax Credit, we are working on a one-time, tax-free boost of up to \$600.

Support for Students



The Canada Emergency Student Benefit (CESB) is providing \$1250 per month, up to \$2000 for those living with disabilities, to over 1 million students and recent graduates. You can apply from May to August through your **CRA MyAccount.**

This year, we have also created 281 jobs for youth in Mississauga-Erin Mills and 76,000 across Canada through the Canada Summer Jobs Program. Local postings can be found at jobbank.gc.ca

Support for Workers



Since launching in April, The Canada Emergency Response Benefit (CERB) has provided \$43 billion to support over 8 million Canadians who lost their income due to COVID-19. Applications are still available through your CRA MyAccount and you must reapply for each 4-week period.

Other supports for Canadians include:

- Doubling the GST/HST credit for this year, which was delivered in April
- Deferring income tax payments until September 2020
- Delivering a Climate Action Rebate of approximately \$448 per family

Support for Businesses and Nonprofits



The Canada Emergency Business Account (CEBA) has provided over 665,000 eligible businesses with a \$40,000 loan, guaranteed by the government and interest-free for the first year. This is available through your local financial institution.

The Canada Emergency Commercial Rent Assistance (CECRA) provides forgivable loans to qualifying property owners to cover up to 50% of monthly rent payments, from April to June 2020, under the condition that they lower rent for their tenants by 75%.



We have devoted \$962 million to support regional economies through the Regional Relief and Recovery Fund (RRRF), available for Mississauga-Erin Mills through FedDev Ontario.

For enterprises of all sizes we have expanded Business Credit Availability Program loans through the **Business Development Bank of Canada (BDC)**.



The Canada Emergency Wage Subsidy (CEWS) is providing \$75 billion to over 344,000 businesses, helping retain over 2.6 million Canadian jobs. The CEWS covers 75% of employee wages, up to \$847 per week, and is available through your organization's CRA MyBusiness account.





We have also invested \$50 million to support women's shelters across Canada and \$100 million in food security, with 50% going to Food Banks Canada.

Support for Canadians Abroad



The Registration of Canadians Abroad (ROCA) is a free service that provides important emergency updates to Canadian citizens currently stuck outside of Canada. You can register at travel.gc.ca/travelling/registration

Our government has committed \$100 million to support food programs, and I encourage you to support these essential services if you are able to. On my end, I have donated to the Mississauga Food Bank and Eden Food For Change here in Erin Mills.



VIRTUAL PARLIAMENT SESSIONS

In order to follow safe physical distancing practices, House of Commons proceedings for the COVID-19 committee, comprised of all sitting MPs, resumed through virtual attendance. In these sittings I have raised the concerns that matter most to our riding, including the conditions in long-term care facilities and support for municipalities like the City of Mississauga. Working remotely, I will continue to advocate for the needs of Mississauga-Erin Mills.

OUR INVESTMENTS

By the Numbers

- \$14B to support our provinces as we kickstart our economic recovery
- Up to \$3B for pay top-ups to essential workers with lower incomes
- \$2.2B delivered to Municipalities through the Federal Gas Tax Fund
- Over \$1B into medical research on COVID-19
- \$350M to support charities and nonprofits
- \$50M to support women's centres and sexual assault centres
- \$750M to create the Emissions Reduction Fund
- \$250M direct funding to support farmers, food businesses, and food processors
- \$100M to support Food Banks and food services across Canada
- \$20M to the Canadian Food Inspection Agency
- \$62.5M for the new Canadian Seafood Stabilization Fund
- \$500M COVID-19 Emergency Support Fund for Cultural, Heritage, and Sports Organizations
- \$157.5M to support homeless Canadians
- Over \$2B to procure Personal Protective Equipment (PPE)
- \$962M to support regional economies through the Regional Relief and Recovery Fund (RRRF)
- \$650M for COVID-19 health response and income support for Indigenous communities
- \$90M for services to Indigenous peoples living off reserve & in urban centres
- \$430M to support Indigenous-owned businesses manage the impacts of COVID-19

SUPPORTING A SAFE RESTART WITH ALL LEVELS OF GOVERNMENT

Our government is ready to provide provinces with \$14 billion to provide the things Canadians need over the next 6-8 months. As part of this safe restart agreement, we are establishing a standard of support to keep every Canadian safe and healthy. That means we are discussing personal protective equipment for healthcare and businesses, safe and affordable childcare as parents return to work, immediate assistance to seniors and vulnerable Canadians, sick pay up to 10 days and pay top-ups for essential workers, and building on our government's \$2.2 billion commitment to support municipalities like Mississauga that are taking on the costs of keeping residents safe.

INVESTMENTS IN MEDICAL RESEARCH

We are investing more than \$1 billion in support of a national medical and research strategy to address COVID-19. This strategy includes vaccine development, the production of treatments, and the tracking and testing of the virus.

We have also created the COVID-19 Immunity Task Force to oversee a series of countrywide blood test surveys that will tell us how widely the virus has spread in Canada. The task force is providing data that will help us understand the impact of COVID-19 on vulnerable populations, while also leveraging new and existing lab capacity for research.

FOOD SECURITY AND AGRI-FOOD INDUSTRY

To ensure Canadians have a safe and reliable food supply, we are investing over \$250 million in direct funding as well as making important changes to agriculture programs to support farmers, food businesses, and food processors who are working hard every day. This includes:

- A national AgriRecovery initiative of up to \$125 million in funding to help producers faced with additional costs incurred by COVID-19 and changing the program so it now covers 90% of eligible expenses, from 70%.
- A Surplus Food Purchase Program with \$50 million designed to help redistribute existing and unsold inventories to local food organizations serving vulnerable Canadians.
- Working with the provinces and territories to allow producers to access 75% of their AgriStability payments to help with anticipated income losses.

MOBILIZING CANADIAN INDUSTRIES

We launched Canada's Plan to Mobilize Industry to Fight COVID-19 to help companies that are already making things like masks, ventilators, and hand sanitizer massively scale up production, as well as provide support to those who want to retool their manufacturing facilities to contribute to this fight. We have spoken to more than 2,900 Canadian companies offering their support and started inking deals with many of them. As of June 2020, we have:

- Secured more than 340 million surgical masks, 107 million of which have been delivered.
- Purchased 30,000 made-in-Canada ventilators.
- Ordered roughly 121 million N95 masks.
- Received nearly 39 million pairs of medical gloves.
