Federal Benefits and Credits

Canada Child Benefit (CCB)

A monthly, tax-free benefit for eligible families with kids under 17, with a supplement for kids under 6 and kids with disabilities. Payments are indexed to increase regularly the consumer price index.

You can apply to start receiving this payment when you receive your child's birth certificate.

Climate Action Incentive Payment (CAI)

A quarterly, tax-free payment for residents in Ontario and other provinces. The amount increases regularly to ensure that you are receiving more than what is paid to the price on pollution.

You will receive this payment automatically after filing your taxes each year.

Canada Pension Plan (CPP)

A monthly, taxable benefit for Canadian seniors who contributed to their CPP before retirement. You may choose to start receiving your CPP starting at 60 and no later than 70.

You must apply to start receiving this payment.

Guaranteed Income Supplement (GIS)

A monthly, tax-free income supplement for seniors who have a lower income and already qualify to receive Old Age Security.

Most eligible Canadians are automatically enrolled and will not need to apply.

Old Age Security (OAS)

A monthly, taxable benefit for Canadians starting at age 65, with an increase when you turn 75. The amount paid increases regularly with the consumer price index.

Most Canadians are automatically enrolled at age 65. You must have resided in Canada for at least 10 years to qualify.

Advanced Canada Workers' Benefit (CWB)

A refundable tax credit to support low-income workers. An additional supplement is available to those who live with a disability. As of July 2023, you can receive up to 50% in advance through three payments during the year.

You must complete Schedule 6 when filing your taxes to receive this benefit.
