## LETTER FROM IQRA

Dear friends,

Happy summer! I hope you are finding time to relax with friends and family and enjoy the beautiful weather.

Firstly, I want to thank you, from the bottom of my heart, for placing your trust in me once again to be your Member of Parliament. I am truly humbled to have this opportunity to continue serving our beautiful riding of Mississauga-Erin Mills, and I vow to work hard to be the strong voice our community deserves.

In April, Canadians made a clear choice, that in a changing world, we will work together to build Canada strong under Prime Minister Mark Carney's leadership. Following the election, I have had a productive few months meeting with residents and advocating for our local priorities in Ottawa.

This new session began with a historic Throne Speech from His Majesty, King Charles III, reaffirming Canada's sovereignty and outlining our plan to build a stronger economy for everyone. We are **cutting your taxes** to help save the average family up to \$850 each year. We will bring home ownership back into reach by **cutting the GST on new builds for first-time home buyers**, saving up to \$50,000.
